
# ARCTIC FUTURES SYMPOSIUM 2022 BIOGRAPHIES OF SPEAKERS AND MODERATORS





Torbjørn Aag
Project Manager, Kunnskapsparken Helgeland, Nordland County

Torbjørn Aag is project manager and business developer at Kunnskapsparken Helgeland AS.

He works with the development of competence initiatives for businesses and connecting companies to public funding agencies, instrument apparatus and R & D.

Kandidat Helgeland is a regional trainee program where we recruit young people with a high level of formal educationd to the region's business life, public enterprises and some municipalities. The trainees are employed in various companies while as facilitators we organise an attractive onboarding program with management courses, networking initiatives and social gatherings for the trainees.

Torbjørn has worked with Kandidat Helgeland since its establishment in 2010. In 2022 the trainee scheme recruited 168 candidates to Helgeland, and around 75% are still in the region.

Torbjørn is also concerned with the tourism and culture industry and is involved in projects as a facilitator for innovation and competence development.



**Pita Aatami** *President, Makivik Corporation* 

Mr Pita Aatami was elected President of Makivik Corporation in January 2021. He previously held the position from 1998-2012. From 2013 – 2020 he was the President and CEO of Air Inuit, a wholly-owned Makivik Corporation subsidiary.

His history with Makivik Corporation goes back to 1987 when he was elected Board Member for the community of Kuujjuaq, where he grew up. In 1993 he was elected Treasurer of Makivik Corporation, a position he held until becoming President in 1998.

Mr Aatami was previously Chairman of First Air, President of Kuujjuamiut, Halutik Enterprises, and Director of Air Inuit and Seaku Fisheries. He is the past President of the Nayumivik Landholding

Corporation in Kuujjuaq, and was the Deputy Mayor of Kuujjuaq for ten years, as well as the past President of the Kuujjuaq Recreation Committee. He started the Kuujjuaq Youth Camp in his community.



Kristín Linda Árnadóttir Deputy CEO, Landsvirkjun

Kristín is the Deputy CEO at Landsvirkjun, which is Iceland's largest power-producing company, producing 100% renewable energy from hydroelectric, geothermal and wind facilities. Landsvirkjun is one of Europe's largest renewable energy producers.

Kristín is the former Chair of the Arctic Council's Expert Group on Black Carbon and Methane (EGBCM). The group's main objective is to assess and report on the progress of the implementation of the Arctic Council's Framework for Action on Black Carbon and Methane.

Kristín was Director General at the Environment Agency of Iceland for over 12 years and participated actively in environmental issues relating to the Arctic.



Forest Banks

Project Development Manager, Battelle

Mr Forest Banks is a Program Development manager for Battelle and has been supporting scientific research for the past 20 years. Primarily focused on remote operations in logistically challenging locations, Forest's research support has included managing Systems Integration/Remote Sensing installations for the National Ecological Observatory Network, operations and construction of the IceCube Neutrino Detector at the South Pole, and integration of the Lowell Discovery Telescope in Happy Jack, Arizona. His work has taken him to over 70 countries, and he's particularly drawn to the polar regions.

Forest strongly focuses on community collaborations, indigenous culture and inclusion, workforce development and STEM education.

Forest lives with his wife and two kids in the foothills of Northern Colorado and enjoys carpentry, mini-farming, Fishing, beer, and Nordic travel.



**Erik Bergkvist** 

Member of the European Parliament, Social Democratic Party

Dr Erik Bergkvist has been a Social Democratic member of the European Parliament since 2019 and the voice of Northern Sweden in Europe. His focus is to create an equal Europe, both within and between Member States. The Union's regional and growth policy is at the heart of this work.

Dr Bergkvist has a good deal of political experience, both as a chair of the Northern Region Västerbotten and as a municipal board member in his home city of Umeå. He holds a PhD in Economics from Umeå University.

Dr Bergkvist worked with Arctic-related issues in his role as a regional politician in Västerbotten and in the context of his engagement on a European level. He is a member of the European Parliament's committee of regional development and the Arctic Friendship Group. He was recently elected as Vice-chair in SEArica with a special focus on Arctic matters. Furthermore, he has also been Vice-chair for the Conference of Peripheral Maritime Regions of Europe (CPMR).



Nicole Biebow

Project Manager, EU PolarNet, Alfred Wegener Institute

Dr Nicole Biebow is the Coordinator of the EU project EU-PolarNet 2, having previously served as Executive Manager of EU-PolarNet 1. She is also the Coordinator of the EU-funded Arctic Research Icebreaker Consortium (ARICE). In October 2021, she was elected Chair of the European Polar Board (EPB).

She leads the International Cooperation Unit at the Alfred-Wegener-Institute (AWI) in Germany and is responsible for all international relations of the AWI. She maintains an extensive network of contacts in the European/International science and policy communities.

Nicole received her PhD in Marine Geology at GEOMAR in Kiel in 1996.



Geneviève Brisson

Déléguée Général, Québec Government Office in Brussels

Geneviève Brisson took up her position as Delegate General of Québec in Brussels on January 17, 2022. Before her appointment, she was employed as a senior director of global government affairs at Enerkem, a company offering high-tech solutions to produce advanced biofuels and renewable chemicals from non-recyclable waste.

Throughout her career, Geneviève Brisson has occupied many strategic positions in government and institutional relations, as well as in business development in the energy and environment sectors, and in Indigenous affairs.

She previously worked for several major Québec energy industry players, including Hydro-Québec, one of the world's leading producers of hydroelectricity, and Énergir, Québec's main distributor of natural gas.

Ms Brisson also boasts solid experience in the areas of government and policy. For instance, she worked as a political advisor on both Aboriginal Affairs and Northern Development in Canada's House of Commons and in the National Assembly of Québec.

Ms Brisson's diverse professional experience and her renowned engagement and leadership have earned her key roles in numerous networks and an appointment as Co-Chair of Conseil des Entreprises en Technologies Environnementales du Québec (CETEQ). She has also served as a board member for several companies and organizations, including Écotech Québec (which represents clean technologies), SWITCH (alliance for a green economy), Association québécoise de production de l'énergie renouvelable (AQPER), and Connexion internationale de Montréal.

Geneviève Brisson holds a degree in political science from Université du Québec à Montréal and also completed a year in northern studies at the University of Stockholm.



Patti Bruns
Secretary General of the Arctic Mayors' Forum

Patti has been Secretary General of the Arctic Mayors' Forum since August 2022. Patti came to the AMF from the Canadian International Arctic Centre where she served as Senior Policy Advisor. She previously held the position of Executive Secretary of two Arctic Council Working Groups – ACAP (Arctic Contaminant Action Program) and EPPR (Emergency Prevention Preparedness and Response). Patti has a deep knowledge of the Arctic through her work with the government, multilateral fora and the consultancy sector.



#### **Melody Brown Burkins**

Director, Institute of Arctic Studies, Dartmouth University; UArctic Chair in Science Diplomacy and Inclusion

Dr Melody Brown Burkins is the Director of the Institute of Arctic Studies, Senior Associate Director in the John Sloan Dickey Center for International Understanding, and Adjunct Professor of Environmental Studies at Dartmouth. With over 30 years of experience as a polar scientist working in both academia and government, she is an advocate for policy-engaged scholarships, experiential education, and the support of science policy and diplomacy initiatives advancing sustainability, equality, and inclusion in the Arctic and around the world.

Dr Burkins was born and raised in Fairbanks, Alaska, and has a deep appreciation of the issues facing Arctic communities. Her career - spanning polar science, policy, and diplomacy - includes service as the energy and environment advisor to US Senator from Vermont Patrick Leahy, as the first female Chair of the US National Committee to the International Union of Geological Sciences, Chair of the US National Academies' Board on International Science Organizations (BISO), and Governing Board member of the International Science Council (ISC). Today, in addition to her role as UArctic Chair, she is honoured to serve as Special Advisor and Assembly Representative to the UArctic global network, as a Foundational Fellow of the ISC (FISC), and as a member of the 4th International Conference on Arctic Research and Planning (ICARP IV) Steering Committee.

Burkins earned her B.S. in geology at Yale and both her M.S. and PhD at Dartmouth, focusing her doctoral studies on earth, climate, and ecosystem studies in the Antarctic Dry Valleys.



#### **Marie-Anne Coninsx**

Former Ambassador at Large for the Arctic, European Union; Senior Fellow, Egmont Institute; Board Member, International Polar Foundation

Marie-Anne Coninsx was the first EU Ambassador at Large for the Arctic (2017 - 2019) before her retirement after 35 years as an EU official. During her career as a European diplomat, she was the EU Ambassador to Canada and EU Ambassador to Mexico, and served at EU Delegations with the United Nations in New York (US) and Geneva (Switzerland), providing her with extensive experience in multilateral issues.

She began her career in the Legal Service of the European Commission and worked for 12 consecutive years as a Staff Member in the Cabinets of three Commissioners. She also worked in the External Relations Department at EU HQ, overseeing relations between the European Union and Latin America.

Ms Coninsx studied law at Ghent University (Belgium) and carried out her post-graduate studies at Cambridge University (UK) and at the European University Centre in Nancy (France). As a Belgian citizen, she is fluent in Dutch, French, English, German, and Spanish.



François Delhaye

Director, Directorate of Economic Affairs, Belgian Ministry of Foreign Affairs

Joining the Belgian Foreign Service in 1933, Mr François Delhaye has served as First Secretary for the Belgian Embassy in Riyadh (KSA) and for the Belgian Permanent Mission to the IAEA, Vienna (Austria). Between 2007 and 2009, he worked as Deputy Spokesman for the Ministry of Foreign Affairs. Before that, he also served as Economic Counsellor and Minister Counsellor for the Belgian Embassy in Kinshasa (RDC).

Between 2009 and 2011, Mr Delhaye worked as Deputy Permanent Representative to NATO (Brussels). After this, and until 2014, he

worked for the Cabinet of the Belgian Minister of Foreign Affairs as Security and Defense Adviser. Until 2018, Mr Delhaye then served as Ambassador to the Islamic Republic of Iran and, until 2022, as Ambassador to the Republic of India. Now, he holds the position of Director of the Economic interests section at the Belgian Ministry of Foreign Affairs.

Mr Delhaye studied Political Science at the Université Libre de Bruxelles and obtained a Diploma in International Relations from the Johns Hopkins University – Bologna Centre. He also speaks French, Dutch, English, and German fluently.



**Hákun Djurhuus**CEO, SEV (Faroese electric utility company)

Hákun Djurhuus has been the CEO of the Faroese electric utility company SEV since 2008. Before taking on his current position at SEV, he was the Managing Director of Shell in the Faroe Islands. Hákun holds an MSc in Civil Engineering from the Technical University of Denmark.

SEV has received the Nordic Council Nature and Environment Prize for its ambitious targets and the creative nature of its efforts to reduce dependency on fossil fuels to reach its target of a 100% renewable energy supply onshore by 2030.

The Faroe Islands are a small but highly advanced country isolated in the North Atlantic. The green transition in the Faroe Islands will demonstrate how quickly and effectively converting to a sustainable energy sector works and can serve as a demonstration case and a testbed for larger communities.



Angelina J. F. Eichhorst

Managing Director Europe, European External Action Service of the European Union

Ambassador Angelina Eichhorst has been the European Foreign Service Managing Director EUROPE since September 2021. Before that, she was the Acting Managing Director then the Managing Director for Europe and Central Asia (2019-2021), the Deputy Managing Director/Director for Western Europe, Western Balkans and Turkey and the Chief Negotiator for the EU-facilitated Belgrade Pristina Dialogue (2015-2019).

Since 1996, Ms Eichhorst has served with the European Union at different external relations Directorates General in Brussels, Jordan and Syria. In Lebanon, she was the EU Ambassador/Head of Delegation (2011-2015). She also worked in Egypt, Somalia and New York in the private sector, the United Nations, research institutes and non-governmental organisations (1989-1996).

Born in the Netherlands, Ms Eichhorst holds a Master's Degree in languages and cultures of the Middle East and in International Relations. She also holds postgraduate diplomas in international law, human rights and the law of international organisations. She freely converses in Dutch, English, French, German and Arabic, and has a good understanding of Italian and Spanish.



#### Gizrem Ezras

Head of Section and Counsellor for Agriculture, Fisheries and Environment, Mission of Canada to the EU

Gizem Eras joined the Canadian Mission to the EU in August 2022 as Head of Section and Counsellor for Agriculture, Fisheries and Environment.

Prior to her assignment in Brussels, she was posted for 5 years to the Canadian Embassy in Washington, D.C. as the Agriculture and Fisheries Counsellor.

She has worked at Agriculture and Agri-Food Canada and Global Affairs Canada in Ottawa, Canada in various areas of trade policy, including in trade in goods and services, tariffs and non-tariff barriers, geographical indications (Gls), pharmaceutical patents and trade remedies. Since 2005, Gizem has also been involved in numerous free trade agreement negotiations for Canada, including the Canada-EU Comprehensive and Economic Trade Agreement (CETA), the Trans-Pacific Partnership (now the CPTPP) and the Canada-US-Mexico trade agreement. She also has private sector experience as an olive oil exporter.

Gizem has served as a board member of the Women in International Trade (WIIT) D.C. and was the Chair of the Washington Agricultural Roundtable (2020-2021).

Gizem has also lived in Italy, Chile, Bangladesh, Iraq, Turkey and the UK. She has a Master's degree in International Trade Policy and Theory from the Norman Paterson School of International Affairs in Ottawa, Canada and a Bachelor's degree in Business Studies from City University in London, UK.



Frida Fossland

Project Manager, the North Sweden Green Deal, Region Västerbotten

Frida Fossland is the Senior project manager of the North Sweden Green Deal. She has expertise in skill supply and business development at Region Västerbotten.

The North Sweden Green Deal project explores new ways of building the sustainable North Sweden of the future.

The project's total budget is SEK 112,500,000 (≈10,350,000€). The project is being co-funded with 50% funding from the Regional Development Fund. Focus areas in both regions are on attraction of workers, skills supply and sustainable physical planning.



Mads Qvist Frederiksen

Director, Arctic Economic Council

Mads Qvist Frederiksen is the Director of the Arctic Economic Council (AEC). Located in Tromsø, Norway, the AEC is an independent business organization established in 2014. It facilitates Arctic business-to-business activities and sustainable economic development. The AEC provides advice and a business perspective on the work of the Arctic Council.

Before joining the AEC in March 2021, Mr Frederiksen worked as a Senior Advisor in the Global Trade and Investment unit at the Confederation of Danish Industry. There, he was responsible for Arctic business development and policy. Before that he worked as a communication advisor for MADE (Manufacturing Academy of Denmark), as a journalism trainer in Kabul, Afghanistan, and as a journalist for the Danish department of Defense.

In addition to Arctic policy and trade promotion, his previous work was with sanctions and export control, development work, foreign investments, communication strategy, journalism, training, and capacity building.

Mr Frederiksen is originally from Denmark. He holds a Master's degree in Middle East Studies from the University of Southern Denmark and a Bachelor's degree in Journalism and Contemporary history from City University and Queen Mary, University of London.

Mr Frederiksen has lived and worked in Denmark, Norway, Algeria, the United Kingdom, Iran, and Afghanistan.



Clara Ganslandt

EU Special Envoy for the Arctic, European External Action Service

Clara Ganslandt is Head of the Western Europe / Arctic / Regional Division (Europe 1) within the European External Action Service (EEAS) since 2019. The Division is in charge of EU relations with non-EU Western European countries Iceland, Liechtenstein, Norway, Switzerland, Andorra, Monaco, San Marino and the Holy See. The division monitors political and economic developments in these countries and leads political dialogue, covering foreign policy and global issues.

As of 1 September 2022, Clara Ganslandt is also Special Envoy for Arctic Matters. Previously, Clara Ganslandt was Head of the Division for Partnerships and Agreements with Third States and International Organisations (EU-NATO, EU-UN relations in the field of crisis management) within the EEAS Security and Defence Policy Directorate (2015-2019).

Before taking up that position, she was Head of the EEAS Division for Non-Proliferation and Disarmament and Chair of the Council of the European Union's Working Party on Global Disarmament (2011-2015).

Clara Ganslandt is a Swedish national. After her law studies, she entered the Swedish Ministry for Foreign Affairs in 1990. Following Sweden's accession to the EU in 1995, she joined the General Secretariat of the Council of the European Union in Brussels to work on the new structures set up in the framework of the EU's Common Foreign and Security Policy (CFSP).

She joined the European External Action Service at its creation in 2011. She has worked in many foreign policy domains, including non-proliferation and disarmament, legal, institutional and financial aspects of the CFSP and policy coordination.

She holds a Master of Laws (LLM) from Lund University in Sweden and also studied at the College of Europe in Bruges and the Institut d' Etudes Politiques in Paris.

Clara Ganslandt is married with two children. She has a keen interest in jazz music, contemporary art and hiking.



Kjell Giæver

General Manager, Arctic Energy Partners and Chairman, North Norway Energy Cluster (EiN)

Kjell Giæver is the general manager of Arctic Energy Partners and Chairman of the North Norway Energy Cluster (EiN)

Kjell Giæver family's background has historical origins from the German city of Jever (which became Giæver in Norwegian) and is the 12th generation living and working in North Norway since the late 17th century.

**Neil Gray** 

Minister for Culture, Europe and International Development, Scotland

Neil Gray was born and brought up in Orkney and was educated at Kirkwall Grammar School. He graduated from the University of Stirling in 2008 with a first-class Bachelor of Arts Honours degree in politics and journalism.

He was elected to represent Airdrie and Shotts Constituency at the 2021 Scottish Parliament election.

He had previously won the Airdrie and Shotts Westminster seat in 2015 and held it on two subsequent occasions before resigning to stand for the same area in the 2021 Scottish Parliament election.

Before becoming an MP, Mr Gray worked for former Scottish Government Health Secretary Alex Neil MSP as his Airdrie and Shotts constituency office manager.



Lars Haltbrekken
Chair, Arctic Delegation, Norwegian Parliament

Lars Haltbrekken, current Member of Parliament for Sør-Trøndelag, Socialist Left Party, is also a Member of the Standing Committee on Energy and the Environment, occupying this role since October 2017. Since 2021, Mr Haltbrekken is also a Substitute Member of the Election Committee and will occupy the role of Member and Chair of the Delegation for Arctic Parliamentary Cooperation until 2025.

In his early career, Mr Haltbrekken has been an adviser for the Norwegian Farmers and Smallholders Union and chair of the Norwegian Society for the Conservation of Nature.



Alain Hubert

Founder and President, the International Polar Foundation

Alain Hubert is a Belgian explorer, certified mountain and polar guide, a civil engineer, and the President and Founder of the International Polar Foundation (IPF). With the IPF and support from sponsors from the private sector and the Belgian State, he built the the first zero-emission polar research station, the Princess Elisabeth Antarctica.

Alain Hubert obtained his Civil Engineering diploma from the Université Catholique de Louvain (UCL) in 1974. As an adolescent, he became an avid practitioner of outdoor sports including marathons, canyoning, skiing and paragliding.

Alain has always been an entrepreneur who lives for adventure and strives to achieve. Early in his career, he founded a co-op specialising in carpentry and joinery (CHERBAI) in the Ardennes region of Belgium.

He has gone on a number of major polar and mountaineering expeditions. His achievements include being the first Belgian to ever reach the North Pole in 1994 with Didier Goetghebuer, a world record autonomous crossing of Antarctica (3924 km in 99 days) with Dixie Dansercoer in 1998, and five attempts at Mount Everest. The Arctic Arc expedition with Dixie Dansercoer in 2007 was the first ever Siberia-Greenland crossing via the North Pole.

During his expeditions, Alain Hubert witnessed the pace and magnitude of climate change firsthand and decided to dedicate himself to that cause. He collaborates with scientists and collects ground truth data for them during his expeditions (for example snow depth data for the CryoSat mission during the Arctic Arc Expedition in 2007).

In 2002 he founded the International Polar Foundation along with climatologist André Berger and glaciologist Hugo Decleir. The International Polar Foundation supports polar scientific research, promotes informed action on climate change, and the development of a sustainable society.



Morten Høglund

Senior Arctic Official, Ministry of Foreign Affairs of Norway

Morten Høglund was appointed Senior Arctic Official (SAO) for Norway in October 2021 and, before that, as the first dedicated Norwegian ambassador to ASEAN in Jakarta in 2017. Before these postings, Mr Høglund was a Senior Official ASEAN at the Norwegian Ministry of Foreign Affairs and Special Adviser for Arctic Affairs.

Mr Høglund served 12 years in the Norwegian Parliament and 2 years as Deputy Foreign Minister. He has served as Deputy Mayor in two Norwegian counties. As a Member of Parliament, Mr Høglund chaired the Parliament's Arctic delegation and has also been Chair of the Circumpolar Arctic Parliamentary cooperation.

Mr Høglund is married and has four children. He has a long history in Chinese Dragon Boat Racing, including founding the Oslo Dragon Boat Club and co-founding both the European and International Dragon Boat Federation.



Johanna Ikävalko

Director of the Arctic Centre, University of Lapland, Finland

Dr Johanna Ikävalko (b. 1965) dissertated at the University of Helsinki, Finland, in 1997 with hydrobiology/sea ice biology as her main field of research. She has lived and done research abroad, e.g. in Germany (Institute for Polar Ecology), Australia (Australian Antarctic Division) and the US (University of Santa Cruz, California).

After her active career in science, she has moved more to its implementation. From 2009-2013 she was affiliated as the Head of Environment at the Finnish Farmers' and Forest Owners' Association,

after which she was the Head of the Marine Research Unit at the Finnish Meteorological institute. Johanna has also worked as a ministerial adviser at the Ministry of Transport and Communications.

During Finland's presidency at the Arctic Council in 2017-2019, she successfully led the priority "Meteorological Cooperation", after which she worked as an expert for the Arctic Council working group Arctic Monitoring and Assessment Programme Secretariat.

Dr Johanna Ikävalko has been directing the Arctic Centre of the University of Lapland since early 2021.



Tórheðin Jensen

Chief Marketing Officer, Varðin P/F; Chair of the Faroese Council for Research, Development and Innovation

Tórheðin Jensen is CMO at Varðin P/F. Varðin P/F was founded in 1985 and is the largest fishing company in the Faroe Islands with operations covering the whole value chain - from fishing and processing to international sales. He is also a board member in several companies including Nemlia - a Faroese company which develops monitoring technology used in elderly care to ensure a better quality of life.

In 2021 Mr Jensen finished his DBA (Doctor of Business Administration) at Reading University. His thesis was about Knowledge dynamics in the Faroese seafood cluster - Innovations in a Highly Tacit Environment. It was a case study including two in-depth cases, comparing fisheries and salmon farming.

Mr Jensen was recently appointed as the first chair of the new Research and Innovation Council which is tasked to advise the government and the industry about strategic work on research and innovation.



**Moa Johansson** *CEO, Containing Greens* 

Moa Johansson is one of the founders and the CEO of Containing Greens. With studies in Political science and a thesis within the area of Swedish agriculture.

The company was founded in 2020 with the idea to make northern Sweden more self-sufficient and sustainable in the future. Today, the company has taken the idea further through pilot projects and collaborations. The pilot project carried out together with the Swedish

Research Institute in Luleå has shown the potential of the use of waste heat for cultivation in arctic climates. By looking at the untapped resources of Northern Sweden, Containing Greens is constantly working to connect these to create industrial symbiosis locally.

The great motivator for Moa Johansson is to see how the innovation can be scaled up and used throughout the Arctic climate zone, contributing to sustainability one plant at a time.



**Line Kjelsrup** *Cluster Manager, Biotech North* 

Line Kjelstrup is the Cluster Manager for Biotech North, a knowledge-based industry cluster within marine biotechnology and marine health products. Biotech North is located in Tromsø, Norway, and serves the biotechnology and bio marine sectors in the northern part of the country. The goal of the cluster is to increase the members' innovation and competitiveness and consolidate the position of Tromsø as "The Hot Spot for Blue Biotech".

Kjelstrup is from Tromsø and has a Master of Science in Fisheries and Aquaculture from the UiT-The Arctic University of Norway. She has previously worked in the Ministry of Fisheries, Norway Seafoods and NCE Aquaculture. For 7 years she was the fisheries envoy for the Norwegian Seafood Council to Sweden. And for two years she worked as a Program Manager for Arctic Frontiers before she started the job as Cluster Manager for Biotech North in early 2020.



**Kathleen Larkin** 

Arctic Security Officer, Office of Nordic, Baltic, and Arctic Affairs, U.S. Department of State

Kathleen Larkin serves as the Arctic Security Officer at the U.S. Department of State. Ms Larkin joined the State Department in 2013 as a Presidential Management Fellow and served as a budget analyst in the Bureau of Budget and Planning from 2013-2015. **Greg Poelzer** 

Professor, School of Environment and Sustainability, University of Saskatchewan

For over thirty years, Greg Poelzer has engaged in research focused on comparative politics and policy as it relates to Aboriginal-state relations, energy and resource development in the Circumpolar North, capacity-building in northern regions, and northern development. He has written extensively on the historical and contemporary aspects of communities located in the Circumpolar North and the Canadian sub-Arctic, focusing on Aboriginal development, the development of regional infrastructure, and the mining sector. His previous works have also examined community engagement in environmental assessment for resource development and strategic environmental assessments for Arctic offshore energy planning and development. Greg's co-authored book, Arctic Front: Defending Canada in the Far North was awarded the Donner Prize for excellence and innovation in Canadian public policy writing.

Greg is a Professor in the School of Environment and Sustainability (SENS) at the University of Saskatchewan. He is the Co-Director with Bram Noble of the SSHRC Partnership Grant (2019-2026) Community Appropriate Sustainable Energy Security (CASES), which spans 17 Indigenous and Northern communities across Canada, Alaska, Norway, and Sweden. He is Co-Lead, with Beth Rink, of the Fulbright Arctic Initiative III.

Greg also serves as an Advisor and Negotiator for SaskPower, working toward a global settlement with a major First Nation in northern Saskatchewan that will resolve historical issues and build new relationships going forward. A political scientist by training, his deep connections with industry, government, and Indigenous communities in Canada and across the circumpolar states are successfully driving both initiatives.



**Séverin Schnepp** *European Affairs Manager at Terma* 

Séverin has headed Terma's Brussels office since February 2022. An experienced professional in European affairs, he is responsible for developing and promoting Terma's European footprint and representing its positions in various EU and NATO forums. He also oversees Terma's

participation in research and development programmes, including the European Defence Fund.

An Alaskan by birth, Dr Sfraga is a trained geographer with a focus on the changing geography of the Arctic and Antarctic landscapes, Arctic policy, and the impacts and implications of a changing climate on political, social, economic, environmental, and security regimes in the Arctic.

Dr Sfraga served as a distinguished co-lead scholar for the U.S. Department of State's inaugural Fulbright Arctic Initiative from 2015-2017, a complementary program to the U.S. Chairmanship of the Arctic Council. president, faculty member, department chair, and associate dean. In 2015 Peter Sköld was appointed Honorary Consul of Västerbotten to Latvia and in 2016 he was appointed official Climate Ambassador of Västerbotten.
